Approval of Minutes:

TIRE Update:

Judge Mahoney provided an update on the waste-tire program: since the previous meeting, nothing new has been brought up. The \$5 million abatement money that was just approved by Arkansas State Legislatures has been broken down and only \$1 million will be used on abatement purposes across the State.

Next Friday, there is a waste tire meeting scheduled in Clark County to discuss any further movement within the program.

Staff Report:

Courtney Decker and Dwayne Pratt introduced the request for a Small Unmanned Aircraft system to be utilized by Environmental Officer Decker during illegal dump investigations. The drone program would be shared amongst the PDD programs for post-disaster services and mapping needs amongst the Counties. The Board requested additional indemnity, insurance and maintenance costs be provided at next meeting so a motion can be made.
